

Mayor Fernandes called the meeting to order and requested those present to join her in the Pledge of Allegiance to the Flag.

2. Mayor Fernandes read the following statement:

"GOOD EVENING LADIES AND GENTLEMEN. THIS MEETING IS NOW CALLED TO ORDER. IN LINE WITH THE BOROUGH OF SEA BRIGHT'S LONGSTANDING POLICY OF OPEN GOVERNMENT, AND IN COMPLIANCE WITH THE "OPEN PUBLIC MEETINGS ACT", I WISH TO ADVISE YOU THAT ADEQUATE NOTICE OF THIS REGULARLY SCHEDULED MEETING HAS BEEN ADVERTISED IN THE COURIER ON JANUARY 10, 2008 AND POSTED ON THE BULLETIN BOARD IN THE BOROUGH OFFICE. IN EACH INSTANCE, THE DATE, TIME AND LOCATION OF THIS MEETING WERE PROVIDED IN THE NOTICE. THIS MEETING IS OPEN TO THE PUBLIC."

3. **ROLL CALL:**

4. **INTRODUCTION** - Monmouth County Sheriff, Kim Gaudagno introduced Chief Ramsey of Monmouth County's 911 Communications Center. Sheriff Guadagno said that the FCC passed a mandate several years ago requiring all municipalities nationwide to use narrow banding for their radio system by 2011 and no later than 2013. Monmouth County is the last county in New Jersey that has adopted narrow banding.

She said that Monmouth County will invest 20 million dollars by 2011 to upgrade its radio system infrastructure. It is the responsibility of the Municipalities to purchase radios equipped for narrow banding. Municipalities are invited to join the County to purchase radios to offset high prices allowing affordability. Sea Bright would need to incorporate the costs of the radios in its budget. Monmouth County will be purchasing 1800 radios.

Communication Officer of Sea Bright's Fire and Police Department Pat Mason said that Sea Bright has upgraded its Communication system and is 90% compliant for narrow banding. The FCC adopted the narrow band on February 12, 2003 and the implementation dates in the FCC's plan is for 2013 for non-public safety agencies and 2018 for public safety agencies. He said that he has not seen any information regarding years 2011 and 2013. He said that he is President of the Mid-Monmouth Mutual Aid Association with 28 towns as members. The switch would be to a UHF trunked radio system from our current VHF analog. There are 138 fire companies in Monmouth County and over 75 first aid squads and 48 police departments that use VHF radios which then can be used for the mandated narrow banded frequencies. However, UHF is not mandated and switching to UHF frequency would result in thousands of radios in the County rendered useless. Sheriff Guadagno said that the County was going to use UHF and not VHF.

Whereas, Myasthenia Gravis is one of the major neuro-muscular disorders affecting residents Of New Jersey; and

Whereas, it is fitting to recognize the many physicians who demonstrate an untiring effort to treat this disease and search for a cure;

Now therefore, I, Maria D. Fernandes, Mayor of the Borough of Sea Bright, do hereby proclaim the Month of June 2008 as:

On June 2, Mayor Fernandes met with the Mayors of the Shore Regional District. She was told that Monmouth Beach was invited to join FMERPA (Fort Monmouth Economic Revitalization Planning Authority). This information needs to be provided by Friday, June 6. This is federally funded so there would be not cost for the study. She asked for everyone's cooperation with gathering the necessary information.

The next FMERPA ESAC (Emergency Services Advisory Committee) meeting is June 12, at 3 p.m. at the Eatontown Municipal Building. They have asked that Sea Bright send a representative from each Department.

Councilwoman Long made a motion for Sea Bright to join the Fort Monmouth Economic Revitalization Planning Authority Services Study. Second by Councilwoman Markson and adopted upon the following roll call vote:

10. REMARKS FROM THE AUDIENCE: Charles Ignar of 1187 Ocean Avenue had concerns regarding the reduced police presence on the beach. Councilman Keeler said that Chief Moore is working toward having a varied schedule of patrols and they are firm in maintaining beach control despite Sea Bright's tight budget.

Frieda Finegan of Beach Street said that Beach Street's residents were not notified of ongoing construction. The drilling and inadequate parking is posing a problem.

Irene Davenport of Beach Street said that because of the street construction her handicapped parking spot was torn up and she could not park her car in front of her house. The construction company's truck was idling in front of her house causing fumes to enter her home.

Councilwoman Markson said that she would get in touch with the construction company to ask why they did not notify residents.

Charles Ignar of 1187 Ocean Avenue inquired as to whether the Borough owned the Beach from south of the Beach Clubs to Donovan's. Attorney Arnette said that it was unsupervised Municipal Beach and maintained by the Borough.

Pat Mason of 1198 Ocean Avenue said that Monmouth County's decision involving switching municipalities from VHF to UHF radio system would be costly. He said that research is necessary.

Kathy Morris of 23 Island View Way said that the Recreation Department's annual fundraiser, the Beach Bash would be Saturday June 14 from 4-9pm.

11. ADJOURNMENT: There being no further business before the Governing Body. Councilman Scriven made a motion to adjourn the meeting at 8:30 P.M. Second by Councilwoman Markson and approved upon unanimous voice vote.
